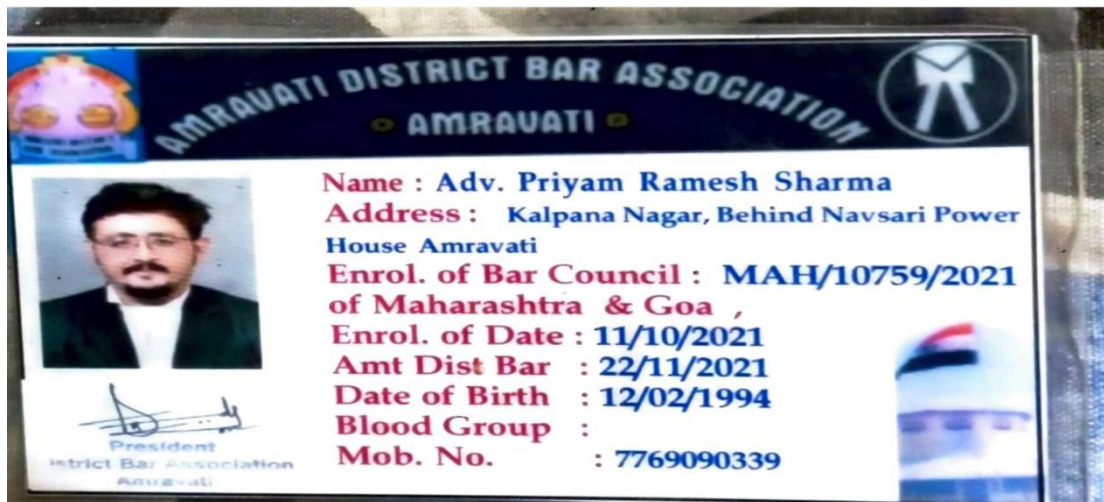
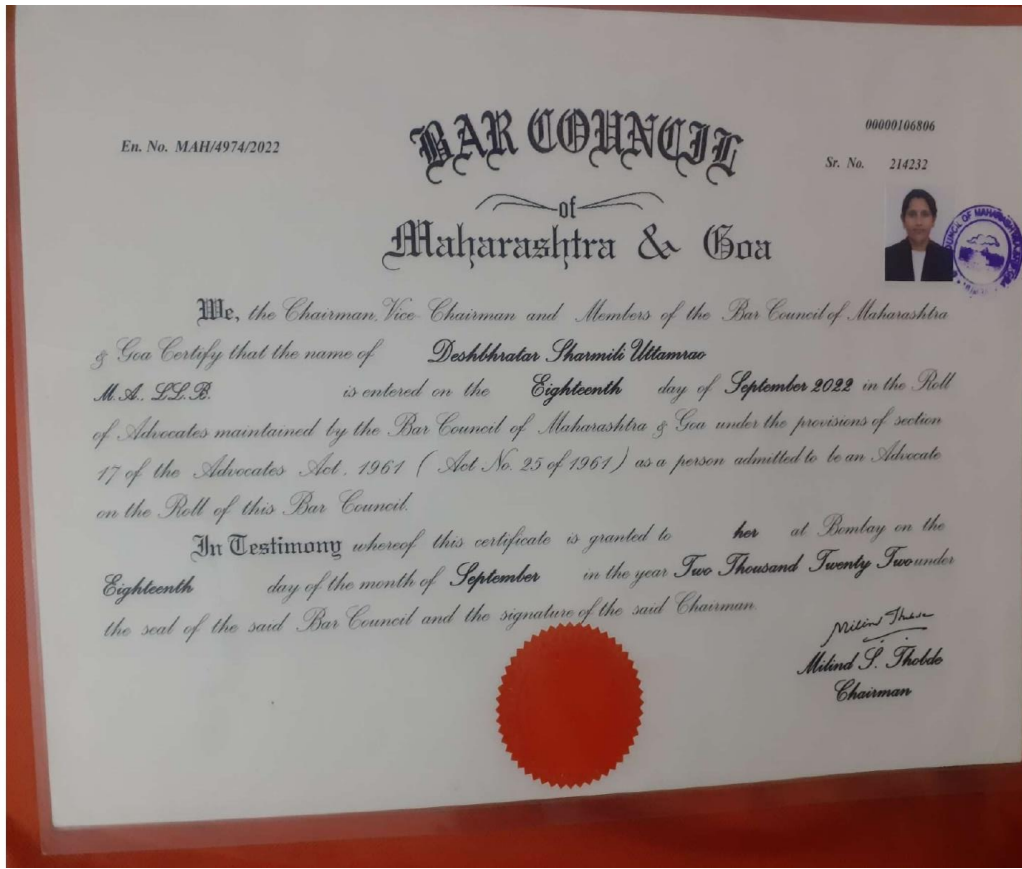
5.2.2.1: Number of Students enrolled with State Bar council (data for last completed academic year)

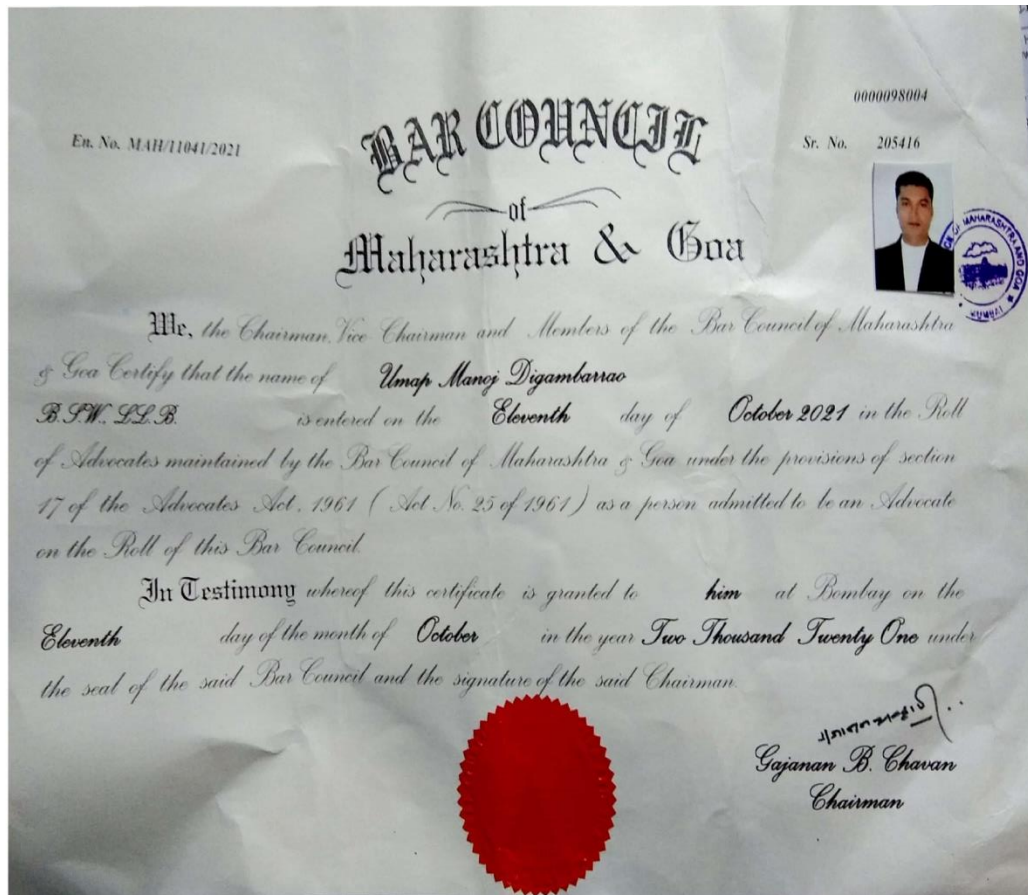
