The Legal Aid Clinic attached to the college is one of the most successfully clinic in the State of Maharashtra.

Dr. Panjabrao Deshmukh College of Law is a first law college in Amravati region serving and educating the masses since independence. The college has given thousands of lawyers, hundreds of judges who as social engineers are serving the society. The college conducts the under graduate course of LLB. (Bachelor of Legum Laws) which is of 3 years duration having an intake capacity of 300 students & LL.B. 5 year duration having a intake capacity of 180 Seats and College is running two years post graduate Degree Course in Law. (LLM.) in the Five specialization with intake capacity of 25 students per subject. Besides the academic progress of the students, the college lays special emphasis on Extra Curricular

Infrastructure of the College

Shri Shivaji Education Society Amravati's Dr. Panjabrao Deshmukh College of Law was introduced as a Law faculty in 1946 as a part of Shri Shivaji College, Amravati. The growth and progress of the law faculty resulted in the separation of the faculty into an independent law college from the Academic Year 1978-79 and then college got a separate building. Presently, the College runs LLB 3 years Degree Course on granted basis, LLB 5 years Degree Course on non-granted basis and LLM (2 years) Post Graduation Degree Course on nongranted basis. Along with this the College has a Research Centre for Ph.D, Moot Association, JMFC Coaching Centre and various other Coaching centers. There is pool of students seeking admissions to these various courses every year. Infrastructure of the college plays an important role for a College running such professional courses and with these growing needs the present infrastructure of the college is found insufficient. For smooth running of all these courses, College visions to have dynamic Annex Building with following facilities:

Imparting professional Legal Education

Legal profession demands that the lawyer should be a responsible citizen and imbibes with the social order of the society. The fine lawyering skills should be inculcated at college level.
