Notice No. 3 CAP Round - III

- ✚ Candidates, who have been allotted their 1st Preference either in Round I or Round II but not reported to the college for confirming Admission are not eligible for Round III. Such candidates can participate in Institutional Round (Round IV).
- ✚ Candidates who have been rejected by the college due to discrepancy in the application are eligible to participate for Round-III.
- ✚ Colleges are Informed **NOT** to verify the details filled in CET Application form as it was only for CET Examination. In any case, college will not force the candidate to submit the Hall Ticket of CET Examination. Colleges have to verify the details filled in CAP Application form only.
- ✚ Candidates who have passed three-year degree examination from any Open University by giving preparatory examination in lieu of HSC should be considered for admission as per the order of Hon'ble High Court of Judicature of Bombay Full Bench at Aurangabad dated 4th May 2022. If Marks filled in the CAP Form are correct then college should admit the candidate by verifying the document. If any discrepancy observed in actual marks & marks filled in CAP form, then college can reject the admission.
- ✚ Only Freeze option is available in the candidate's login to "Freeze" the admission of Round-III. Candidate can freeze the allotted seat of Round-III by paying the seat acceptance fees of Rs.1000/-. (If Seat acceptance fees of Rs. 1000/- is already paid, then no need to pay it again.)
- ✚ Candidates admitted in Round-I ,Round-II & Round-III will have to submit & Upload the Original CVC, TVC, NCL & EWS certificate till the last date of admission of Round-III i.e **14/09/2023**.

- ✚ Colleges should intimate the candidates to submit & upload the Original CVC, TVC, NCL & EWS certificate, who have been admitted in Round-I & Round-II on the basis of receipt of application to obtain Original CVC, TVC, NCL & EWS certificate.
- ✚ Candidates who have been allotted college in Round-III in reserved category seat on the basis of receipt of CVC, TVC, NCL & EWS certificate, then college should verify the Original certificates at the time of admission & Upload the same on the portal. Without Original CVC, TVC, NCL & EWS certificate, college should not admit the candidate. Otherwise, college will be responsible for the wrong admission.
- ✚ No candidate is to be admitted without original CVC, TVC, NCL & EWS certificate in Round-III.
- ✚ The candidates who failed to submit & upload the necessary certificate, their admission shall be cancelled by the college through its login or through online system.
- ✚ These candidate may apply for the Institutional level Round in “OPEN” category, if they meet the requirements and conditions for the open category.
- ✚ If any admitted candidate in Round-I, Round-II & Round-III wish to participate in Institutional Level Round (Round-IV), then he/she will have to cancel his/her earlier admission through college login. Then only he/she will be eligible to participate in the Institutional Level Round (Round-IV).
- ✚ The candidates who had uploaded receipt of the application of CVC/TVC/NCL/EWS in CAP application form and if have not received the documents then he/she should edit application form to be eligible for allocation through Open category in Institutional Level Round (Round-IV) as per the updated schedule displayed on the CAP Portal.
- ✚ There may be very few seats available for Institutional Level Round-IV. Hence, Candidates are requested to seek the admission in the allotted college of Round-III.
- ✚ Probability of vacancy for Institutional Level Round-IV may be very less. Hence, candidates should take a judicious decision for their admission.
